Career Path: Litigation, Mediation + Homebuilder Industry

Early in his career, McKinnie gained experience as an Associate Attorney, learning litigation + mediation with primarily personal injury cases for clients of a small general civil defense law firm. This experience was followed by commercial real estate litigation / arbitration for a boutique firm offering high-quality legal representation to individuals, small companies + large corporations in high-stakes business + personal injury litigation.

As he advanced through several associate attorney roles, Mac experienced and observed client advocacy techniques that serve him to this day. It was also during this time that he cultivated and grew sustainable client-base relationships in commercial / construction.

In 2010, McKinnie moved in-house as General Counsel, Secretary + Director of Human Resources for a nationally renowned privately held enterprise, **McGuyer Homebuilders, Inc. + MHI Partnership, Ltd.** As a multi-departmental leader, he was involved in daily operations as well as M&A work while also overseeing all legal matters intersecting with MHI and 50+ affiliates. **His fortudinous, strategic leadership style,** deal-making and problem-solving resilience enabled MHI to not only survive but thrive through Covid and beyond.

Mac persevered through metamorphic change at the operational helm amid a 4-year integration of the 30-year-old private company into publicly traded national homebuilder **Dream Finders Homes, LLC, from 2021 to 2025.** The merger resulted in DFH’s **twofold increase** in home sales + gross margin / profitability while doubling McKinnie’s workload as he navigated multiple corporate entities.

During the successful post-acquisition transition, McKinnie engaged in **multimillion-dollar land acquisition sales** and land banking contracts + land / lot deals; and, negotiated and mediated **\$100s of thousands in settlements.**
